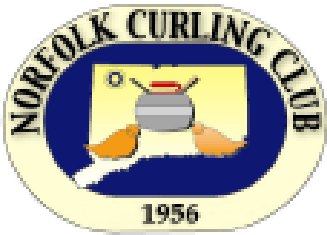

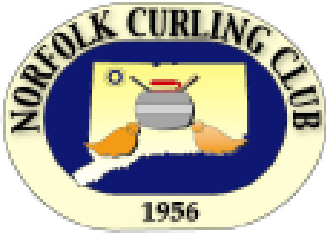

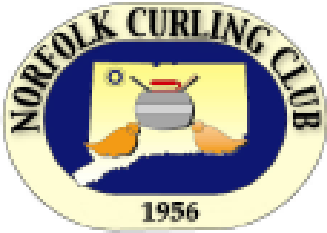

**Eligibility Rules:**

- (a) Members having curled (5) or more curling seasons shall not be eligible to compete. Interpretation: (i) Ten (10) games per season anywhere constitutes a season; (ii) The curling season starts on May 1<sup>st</sup> and ends April 30<sup>th</sup>. (iii) Junior curling but not Youth Curling experience counts towards the five (5) curling seasons.
- (b) All substitutes shall be governed by eligibility rule 8(a) above.
- (c) Each participant is responsible for determining his/her eligibility.
- (d) Each member of the team must be a dues paying member in good standing of the GNCC.
- (e) The Elisabeth Childs Challenge is open to adult curlers ages 21 and over as of the day the event starts.

**Certification (required to be signed by entrant's Club President or Treasurer):**

I certify the above team as qualifying to compete under the aforementioned eligibility rules. I declare this is the primary club of all participants for this event, and that they are dues-paying members, in good standing of the GNCC and the USCA.
